She is a cofounder and director of the Philadelphia Lacan Group; Associate Faculty, Psychoanalytic Studies Minor, University of Pennsylvania; Honorary Member of IPTAR; and Founding Member of Das Unbehagen. Her books include *The Puerto Rican Syndrome* (Other Press, 2003), winner of the Gradiva Award and the Boyer Prize; *Please Select Your Gender: From the Invention of Hysteria to the Democratizing of Transgenderism* (Routledge, 2010); and *Transgender Psychoanalysis: A Lacanian Perspective on Sexual Difference* (Routledge, 2017). She has published two edited volumes (with Manya Steinkoler), *Lacan On Madness: Madness Yes You Can't* (Routledge, 2015) and *Lacan, Psychoanalysis, and Comedy* (Cambridge University Press, 2016). Most recently, she published a collection (with Chris Christian), *Psychoanalysis in the Barrios: Race, Class, and the Unconscious* (Routledge, 2019). She just completed coediting *Psychoanalysis, Gender, and Sexualities: From Feminism to Trans* (Cambridge University Press, forthcoming).
