

Fall 2020 Semester Registration Information

Semester Course Schedule

The Fall 2020 semester begins September 14; classes end December 14. See calendar on page 5.
All classes will be conducted on the Zoom platform.

Registration

A new registration process begins this fall: students will register for classes and supervision sections online using Blackbaud's student portal. Detailed instructions will be provided to students in the coming weeks. One element of registration remains the same, however: **completion of registration is contingent upon having obtained the Advisor's or Fellow's approval and upon submitting the PT 7 pdf form digitally signed by the approved training analyst.**

A **\$150 late fee** will be charged for tuition processed **after September 4, 2020**. After establishing their Blackbaud I.D., students log in to the student portal at [CMPS.mycampus-app.com](https://cmips.mycampus-app.com) to indicate the courses and supervisions they wish to take. This function becomes live on August 14. Students then pay tuition by selecting the appropriate items on the payment contract and indicating a method of payment. Extended payment plans are available.

Registration is finalized only if tuition and the completed PT 7 form are submitted, and if all previously borrowed materials have been returned to the library. Certificate and Research Candidates must be current with their monthly room reports in order to complete registration. Course credit is not given for semester work unless everything has been properly submitted.

The \$100 registration fee covers library services, journal subscription, Center ID card, and all Center mailings.

Leave of Absence

Students who are unable to register for the semester but who wish to maintain their enrolled status send an email requesting a leave of absence to the registrar explaining why they are electing to take a leave. They register for MM Maintaining Matriculation and pay the \$100 Maintaining Matriculation fee to ensure all Center mailings, journal, and library use (except for PEP privileges). Students on leave of absence continue in PT 7.

PT 7 / PT 8 Analyst Statement

The form, signed by the training analyst(s) and returned with the registration form every semester, confirms that the student is in the required weekly analysis and tracks the number of session since the previous PT 7 was submitted. **It is the student's responsibility to report any interruptions in analysis or change in the frequency of sessions to the Advisor or Fellow.** Students in group analysis submit the analogous PT 8 form.

Graduation requirements regarding supervision

CMPS graduation requirements specify a minimum of 200 hours of *individual* supervision comprised of at least 50 hours of PT 311 or **PT 211i** with one supervisor, at least 50 hours of PT 311 with a different supervisor, and at least 50 hours of supervision with a third supervisor, the PT 411 control analyst. At least three different supervisors must be utilized, each of whom provides at least 50 hours of supervision. (The PT 7 individual analyst or PT 8 group analyst may not be a supervisor.) Candidates with larger case loads who need additional supervision may add one or more PT 311 supervisors or enroll in PT 611, but PT 611, as small *group* supervision, does not fulfill any graduation requirement.

Referral Service: Certificate Candidacy and Research Candidacy

Referral Service candidates consult their Fellows and the Referral Service manual for instructions about the appropriate sequence of courses. Candidates assigned Center referrals have all their cases supervised in PT 211*i*, PT 311, PT 411, or PT 611.

Referral Service candidates register for PT 490 Referral Service Lab. Until the Referral Service consulting rooms physically reopen, the Referral Service Lab fee will be divided into two semiannual payments of \$275 for first year students, and two semiannual payments of \$325 beginning with the second year. The fee covers five scheduled referrals, weekly consultation with the Fellow, and telephone answering service.

Scheduling for **PT 211*i*** Beginning Supervision of Consultation and Referral Service Cases, **PT 311** Supervision of Consultation and Referral Service Cases, and **PT 411** Control Analysis of a Consultation and Referral Service Case is privately arranged. **PT 611** Small Group Supervision of Referral Service Cases (Supplemental) is arranged through the Registrar.

Curriculum for Research Candidates

Until their final semester, Research Candidates pay a minimum total in tuition and fees of \$1575 per semester: \$750 for six 50-minute sessions of **PT 527** Directed Research, \$400 for **PT 2612** Seminar in Clinical Practice, Psychopathology, and Psychodiagnosis III, \$325 for **PT 490** Referral Service Semiannual Lab Fee, and \$100 for the registration fee. When the Research Supervisor determines that the final paper is ready for approval, the Research Candidate pays \$390 for the Research Reading Fee (**RF 101**). This covers the cost of final approval of the paper by the second and third readers, two members of the Research Committee other than the Research Supervisor.

Work/Study Program

The Center's Work/Study internships are currently suspended. When the Center physically reopens, students wishing tuition assistance may apply for a Work/Study internship with the Registrar, Mr. Guttman. Areas available will be: Referral Service, library, office work, and computer website assistance. Candidates are paid at an hourly rate. Up to 50% tuition remission can be awarded depending on the skills necessary to fulfill the Work/Study requirements.

Assigned Readings and Library Access

Most classes have a reading assigned for the first class meeting. Please check the reading list for the classes for which you have registered so you can be prepared for the first class.

Since the library will not be physically accessible until the Center reopens, the librarian will be providing other means for access to assigned readings.

New courses replacing discontinued Level 1 requirements

The sudden and unexpected suspension of the Fieldwork program in March 2020 has necessitated a change in Level I required courses. PT 185 and PT 111 will not be offered for an undetermined amount of time. Students who completed one or two semesters of Fieldwork consult their advisors as to how these changes will affect their progress through the program. In general, students who completed the second semester of fieldwork in the spring 2020 semester will be required to take PT 187a *or* PT 187b; students who completed just the first semester of fieldwork in the spring 2020 semester will be required to take PT 187a *and* PT 187b .

Six courses are being added to the program, one of which replaces a previously required course, and one of which is an elective i.e., not required for CMPS students.

- **PT 139 Psychoanalysis, Culture, and Society** (level 1 elective; i.e., not required for CMPS students.)
- **PT 154a Comparative Psychoanalysis, Part 1** (replaces PT 154, a previously required Level 1 course)

- PT 527 Research Supervision/Ethics Taken at least once every semester until approval of the final paper.

Note: In accordance with New York State requirements for licensure in psychoanalysis, CMPS graduation requirements include 45 clock hours of research.

- Students who completed Level 1 at CMPS have met this requirement.
- Students who completed PT 171 and PT 172 before enrolling in CMPS meet this requirement by taking PT 522 (30 clock hours) at Level 2 and a minimum of 15 clock hours of PT 527 (6 clock hours) at Level 3.

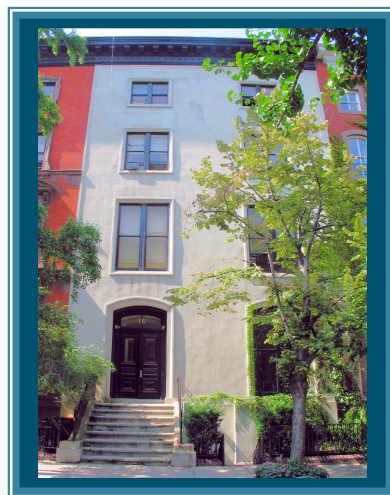

COURSE DESCRIPTIONS OF THE NEW COURSES

PT 139 Psychoanalysis, Culture, and Society

Psychoanalysis can help to illuminate the unconscious structures of culture and the ways in which language and culture frame human experience. This course examines the interface between psychic and social reality and the latent processes of culture as expressed in gender, politics, race, and class. In addition, it focuses on the ways in which culture and society impact psychoanalytic theory and practice, using a sociocultural lens to scrutinize historical and contemporary understanding and treatment of psychotic mental disorders.

PT 181 Somatic Factors: The Biology of Mind and Behavior

In this course, after an in-depth study of neurobiology and neuroanatomy, neurochemistry, genomics, epigenomics, and neuro-psychopharmacology, students will examine the effects of chronic stress, early life stress and various kinds of traumas, including physical/sexual/emotional abuse as well as neglect and social isolation on the brain, gene expression, immune system, other body systems/organs, social functioning and subjectivity. Students will then study the current understanding of resilience from genetic, epigenetic, developmental, psychological and neurobiological perspectives, and the promising new therapies for the promotion of resilience to neural stress. Finally, the effects of various kinds of psychotherapies on brain structure and function, including the impact on genes will be examined.

PT 154a and b, Comparative Psychoanalysis, Parts 1 and 2

Since the first decade of the 20th century, a range of ideas about the fundamentals of psychoanalytic practice has emerged, leading to corresponding shifts in the theories that have been developed to account for the differences in emphasis, and also, in some cases, for elements of the experience itself that differ from what Freud laid out and described originally. The exploration of the differences between groups or schools of analysis, whether substantive or procedural, will be the subject matter of this course. It will also provide the students with a timeline or history of the development of psychoanalysis. Often, debates in the field have emerged around the question of what groups of patients can be treated psychoanalytically. For instance, while some schools consider psychotic patients to be outside the scope of psychoanalytic treatment, other schools have produced considerable research on psychosis, its manifestations, and suitable analytic technique. Similarly, different ways of understanding and treating neurotic and non-neurotic patients will serve as points of departure. We will study the following approaches: Freudian, Ferenczian, Kleinian, independent object relational, American ego psychological, self-psychological, interpersonal, Modern, intersubjective, relational, and Lacanian. Particular attention will be given to concepts essential to clinical practice, such as resistance, transference, countertransference, interpretation, emotional communication, the analytic relationship, and the cure.

PT 187a and PT 187b Critical Observation and Psychoanalytic Listening, Parts 1 and 2

Through fiction and documentary film, guest lectures, and readings spanning clinical theory, case material, and film analysis, this course will develop skills critical to understanding patients—including critical observation and psychoanalytic listening. It will supplement discussion of readings with a laboratory component consisting of visual and audio media focusing on primitive mental functioning. Students will write weekly critiques based on the laboratory viewings that investigate aspects of patient communication, conscious and unconscious symbolic associations, and other issues related to individual countertransference reaction. Subject-matter experts will supplement coursework with case presentations that illustrate core concepts of seeing, hearing, feeling, and thinking in a clinical setting.

NOTES ON EQUIVALENCIES: how courses taken under the old requirements fit into the new requirements:

- Level 1 students who have never taken fieldwork will be required to complete both PT 187a and PT 187b in order to meet requirements for Certificate Candidacy (Level 2).
- PT 187a is offered in the fall; PT 187b is offered in the spring. It is recommended—but not required—that students take PT 187a before PT 187b.
- Level 1 students who have already completed one semester of PT 185 will be expected to complete PT 187a and PT 187b in order to meet requirements for Certificate Candidacy.
- Level 1 students who have completed two semesters of PT 185 will be expected to take either PT 187a or PT 187b in order to meet requirements for Certificate Candidacy.
- Students who have completed fieldwork will not be expected to complete either PT 187a or PT 187b in order to meet requirements for Certificate Candidacy.
- PT 187a and PT 187b may be taken as electives by students for whom they are not required.
- Level 1 students who have already completed PT 154 will not be required to take PT 154a in order to meet requirements for Certificate Candidacy; Level 1 students who have not completed PT 154 will be required to take PT 154a or PT 154b in order to meet requirements for Certificate Candidacy.
- New Level 2 requirements—PT 181 and PT 154b—*do not* apply to current (fall 2020) Certificate Candidates.
- New Level 2 requirements—PT 181 and PT 154b—*will* apply to future Certificate Candidates.
- PT 139 is not a required course for CMPS students.
- Current Level 3 students (Research Candidates) are not affected by the new requirements.
