Syllabus PT 187a Observational Skills and Critical Thinking R. Sacks Fall 2020

NYGSP: 3 Credits

Course Description

Through fiction and documentary film, guest lectures, and readings spanning clinical theory, case material, and film analysis, PT 187a will develop skills critical to understanding patients — including critical observation and psychoanalytic listening.

This two-semester course combines discussion of readings with a laboratory component, consisting of visual and audio media, that focuses on primitive mental functioning. Students will write weekly critiques based on the laboratory viewings that investigate aspects of patient communication, conscious and unconscious symbolic associations, and other issues related to individual countertransference reaction. Subject-matter experts will supplement coursework with case presentations that illustrate core concepts of seeing, hearing, feeling, and thinking in a clinical setting (TBA). This course is three credits per semester.

Objectives

Students will able to:

- identify, describe, and discuss the psychopathology of psychotic disorders including the defense structure of primitive mental functioning;
- identify and articulate countertransference responses experienced while viewing primitive mental functioning; and
- compare and contrast clinical approaches to the understanding and treatment of psychosis.

Laboratory Component

There is a weekly laboratory component done outside the class meeting. Students will view/listen to the assigned laboratory and write critiques based on a prescribed methodology. The methodology will be based on a specific psychoanalytic viewing of film (see Class 2 reading).

Method of Evaluation

- Weekly written critiques (approximately 250 words by email) of the assigned laboratory viewings/listenings
- Personal logs (see log criteria below) submitted to richardjsacks@hotmail.com
- Participation in the class discussions
- Final paper. Final paper will be 8-10 page paper, following the APA format, which focuses on the Class 12 laboratory viewing. Criteria for the final paper will be clarified in class discussion. Final paper must include 5 references from the reading list.

Twelve written logs (approximately 250 words sent by email) are to be completed soon after each class meeting and submitted to the instructor before the following class meeting. The log is a private communication to the instructor enumerating:

- 1. Thoughts, feelings, and reactions to the class discussions.
- 2. A short critique of the assigned reading for that class.
- 3. The final log (Log 12) will be a self-evaluation of how you met the course objectives.

Grading

Students may receive a Pass (P), Low Pass (LP), Incomplete (I), No Credit (NC). Students are evaluated on the basis of attendance, class participation, and the ability to understand, integrate and communicate material from the readings and viewings in the weekly written critiques and class discussions.

To earn a grade of Pass, the student

- Misses no more than two class meetings.
- Demonstrates understanding of the course subject matter in class, including the class presentation.
- Submits 12 logs.
- Demonstrates understanding of the course subject matter in the logs.
- Submits assignments on time.

To receive a grade of Low Pass, the student

- Misses no more than two class meetings.
- Submits 12 logs.
- Demonstrates one or more of the following:
 - Minimal participation in class
 - o Problematic/disruptive participation in class
 - o Minimal understanding of the course subject matter in class discussion or presentation.
 - o All assignments are completed but some are submitted late.
 - o Logs do not regularly address the two stated criteria

To receive a grade of Incomplete, the student

• Does not submit acceptable written work by the last class meeting of the semester or date specified by the instructor.

To receive No Credit, the student

- Does not submit acceptable written work within 30 days after the end of the semester or
- Regularly exhibits disruptive behavior that interferes with the functioning of the class or
- Misses more than two classes.

Academic Honesty:
